### MOTOR VEHICLE DEALERS (LICENSING) REGULATIONS 1974

### Citation

1. These regulations may be cited as the *Motor Vehicle Dealers* (Licensing) Regulations 1974<sup>1</sup>.

### Interpretation

2. In these regulations, unless the contrary intention appears —

"form" means a form in the Second Schedule;

"Schedule" means a Schedule to these regulations;

"section" means a section of the Act;

"the Act" means the Motor Vehicle Dealers Act 1973.

#### Forms Schedules

r. 3

3. Where a provision in the Act is specified in the first column of the First Schedule, the form set out in the Second Schedule, of which the number is specified in the third column of the First Schedule opposite that provision, is prescribed as the form to be used for the purposes of that provision in relation to the matter or thing described in the second column of the First Schedule opposite that provision.

### Particulars prescribed by forms

4. Where a form prescribed by these regulations requires completion by the insertion of particulars or other matters referred to in the form, those particulars or other matters are prescribed as the particulars or other matters required under the provisions of the Act for the purposes for which the form is prescribed.

#### Forms to be completed as directed

5. A form prescribed by these regulations and containing any directions for its completion shall be completed in accordance with those directions.

### False information

**6.** A person who in any application or notice makes a false statement or misleading statement or representation commits an offence.

Penalty: \$200.

### Prescribed period (section 19 (1))

**6A.** For the purposes of section 19 (1) of the Act, the prescribed period is 3 years.

### Prescribed penalty for late application (section 19 (3))

**6B.** For the purposes of section 19 (3) of the Act, the amount prescribed by way of a penalty for a late application is 25% of the appropriate licence fee.

### Fees

7. The fees set out in the Third Schedule are the fees to be paid in respect of the matters to which they are applicable.
