EMPLOYMENT AGENTS REGULATIONS 1976

Schedule

Citation

1. These regulations may be cited as the *Employment Agents Regulations 1976*¹.

Principal Act

2. In these regulations the *Employment Agents Act* 1976 is referred to as "the Act".

Forms set out in Schedule

3. The forms prescribed for the purposes of the Act are set out in the Schedule to these regulations.

Prescribed forms

4. (1) The application forms referred to in the first column hereunder shall be used for the purpose respectively specified in relation thereto in the second column.

(2) The form of licence referred to in the first column hereunder shall be used for the purposes respectively specified in relation thereto in the second column.

(3) Where the transfer of a licence is consented to or ordered under the Act the order to be endorsed on the original licence shall be in the form of Form 10.

Application to be made with prescribed fee

5. An application for the grant, renewal or transfer of a licence shall be made to the Chief Inspector of Factories and Shops and shall be accompanied by the prescribed fee.

Notice of application

6. The notice of application to be published pursuant to subsection (4) of section 18 of the Act shall be in the form of Form 11.

Notice of objection

7. A notice of objection to the grant, renewal or transfer of a licence is not required to be given in a prescribed form.

Form of Register

8. The Register to be kept for the purposes of section 27 of the Act shall be in the form of Form 12.

Certificate of appointment of inspector

9. The certificate of appointment of an inspector pursuant to section 11 of the Act shall be in the form of Form 13.

- (1a) For the purposes of section 13 of the Act, (and subject to the transitional provisions in section 15 of the *Business Licensing Amendment Act 1995*), the following periods are prescribed
 - (a) section 13 (1) a licence should not exceed 3 years in duration;
 - (b) section 13 (1b) a licence may be renewed for 3 years.
- (2) Where a licence is granted to a natural person on behalf of a firm or of a body corporate and an application for the transfer of the licence relates only to the change of the name of that person on the licence no fee is payable; in any other case the licensing officer may fix such fee not exceeding \$300 as he considers appropriate in the circumstances of the case as the fee for the application.
