#### 1. Citation

These regulations may be cited as the *Workers'*Compensation and Injury Management (Acts of Terrorism)
(Final Day) Regulations 2002 <sup>1</sup>.

#### 2. Final day prescribed (section 3)

For the purposes of paragraph (b) of the definition of *final day* in section 3 of the Act, the final day is 31 December 2014.
