Police (Fees) Regulations 1981

1. Citation

These regulations may be cited as the *Police (Fees)* Regulations 1981 ¹.

2. **Fees**

- A fee specified in Schedule 1 is the fee payable for the purpose (1) set out opposite the fee in that Schedule.
- The Commissioner of Police may reduce, waive or refund, in (2) whole or in part, any moneys due under this regulation.

3. Terms used

In these regulations —

accident has the same meaning as in Part V of the Road Traffic Act 1974;

department means the department of the Public Service principally assisting the Minister in the administration of the Act;

road traffic conviction record, in respect of a person, means the record held in the department of the person's convictions against the Road Traffic Act 1974;

As at 01 Jul 2012 Version 03-c0-01 page 1 *traffic infringement notice record*, in respect of a person, means the record held in the department of infringement notices served on the person under the *Road Traffic Act 1974* section 102.
