Police (Fees) Regulations 1981

1. Citation

These regulations may be cited as the *Police (Fees) Regulations 1981*¹.

2. Fees

- (1) A fee specified in Schedule 1 is the fee payable for the purpose set out opposite the fee in that Schedule.
- (2) The Commissioner of Police may reduce, waive or refund, in whole or in part, any moneys due under this regulation.

3. Terms used

In these regulations —

accident has the same meaning as in Part V of the *Road Traffic Act 1974*;

department means the department of the Public Service principally assisting the Minister in the administration of the Act;

road traffic conviction record, in respect of a person, means the record held in the department of the person's convictions against the *Road Traffic Act 1974*;

traffic infringement notice record, in respect of a person, means the record held in the department of infringement notices served on the person under the *Road Traffic Act 1974* section 102.

 - (b) additional copy of documents already disclosed (per hour or part of an hour) \$90.45
