**Petroleum and Geothermal Energy Resources  
(Registration Fees) Regulations 1990**

**1. Citation**

These regulations may be cited as the *Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990*<sup>1</sup>.

**2. Commencement**

These regulations shall come into operation on the commencement of the *Petroleum (Registration Fees) Amendment Act 1990*<sup>1</sup>.

**3. Prescribed amounts**

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of \$4 918.00.
- (2) For the purposes of section 4(3) of the Act, the prescribed amount is an amount of \$4 918.00.
- (3) For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$7 482.00.
- (4) For the purposes of section 4(6) of the Act, the prescribed amount is an amount of \$4 918.00.
