WESTERN AUSTRALIA

FREMANTLE PRISON SITE ACT 1902

AN ACT to repeal an Ordinance passed in the fourteenth year of Her late Majesty, intituled "An Ordinance to vest the site of the Convict Prison at Fremantle in certain officers in trust for Her Majesty, Her Heirs and Successors, for ever," and to confirm certain grants of portions thereof.

Repeal

1. The Ordinance passed in the fourteenth year of Her late Majesty, intituled "An Ordinance to vest the site of the Convict Prison at Fremantle in certain officers in trust for Her Majesty, Her Heirs and Successors, for ever," is hereby repealed.

Re-vesting of certain land in the Crown

2. Subject to the grants mentioned in the Second Schedule, the land described in the First Schedule is hereby vested in His Majesty, His Heirs and Successors, for ever.

Certain grants validated

3. The grants mentioned in the Second Schedule comprising portions of the land described in the First Schedule are hereby validated and confirmed.

Site to become Crown Land

4. Subject to the grants mentioned in the Second Schedule, but notwithstanding the trust recited in the preamble to the Ordinance repealed by this Act, the land described in the First Schedule becomes on the coming into operation of the *Fremantle Prison Site Amendment Act 1957*, Crown land for the purpose of, and thereafter may be dealt with as Crown land under, the *Land Act 1933*.

The First Schedule

Fremantle Lot CD, contents 39 acres 1 rood, more or less. Bounded on the *South-West* by a line about 3 chains 60 links in length, extending in a direction East 34 degrees 52 minutes South along South Terrace from the South-West end of Henderson Street, then by a line about 6 chains 55 links in length in direction East, 50 degrees 7 minutes South along South Terrace aforesaid, and by a line about 4 chains in length, extending East 64 degrees 39 minutes South along South Terrace, to a prolongation of the North-West side of Arundel Street; on the *South-East* by about 10 chains 95 links of said prolongation, extending North 50 degrees 7 minutes East, then by a line about 3 chains 52 links in length, extending North 5 degrees West, and by a line about 10 chains 60 links in length, extending East 5 degrees North; on the *East* by a line about 13 chains 52 links in length, extending North 5 degrees West; and on the *North* by a line about 10 chains 60 links in length, extending West 5 degrees South, then by a line about 5 chains 38 links in length, extending South 65 degrees 45 minutes West, then by a line about 2 chains 74 links in length, extending South 27 degrees West, then by about 3 chains 56 links of the South-West side of Queen Street, extending West 27 degrees North, and finally by the South-East side of Henderson Street aforesaid, extending South 27 degrees West to South Terrace aforesaid—all bearings and boundaries here given being true or thereabouts, and an iron boundary mark being fixed at every angle or corner of the land herein described.

The Second Schedule

A Grant, dated 23 January 1889, from Her late Majesty Queen Victoria to the Commissioners of the Presbyterian Church in Western Australia, of Fremantle Town Lot 1360.

A Grant, dated 11 June 1894, from Her late Majesty Queen Victoria to the Mayor, Councillors, and Burgesses of the Town of Fremantle, of Fremantle Town Lot 1372.

A Grant, dated 16 April 1896, from Her late Majesty Queen Victoria to Elias Solomon and William Frederick Samson, of Fremantle Town Lot 1375, in trust for a place of worship for the members of the Jewish Church.

A Grant, dated 3 August 1897, from Her late Majesty Queen Victoria to the Mayor, Councillors, and Burgesses of the Town of Fremantle, of Fremantle Town Lots 1376 and 1380.

A Grant, dated 28 July 1899, from Her late Majesty Queen Victoria to the Mayor, Councillors, and Burgesses of the Town of Fremantle, of Fremantle Town Lot No. 1386.
