BREAD ACT 1982 INTERPRETATION ACT 1918

Bread Regulations 1983

Made by His Excellency the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Bread Regulations* 1983.

2. Commencement

These regulations shall come into operation on 1 March 1983.

3. Interpretation

In these regulations unless the contrary intention appears — "Schedule" means the Schedule to these regulations; "the Act" means the Bread Act 1982.

4. Certificate of appointment inspection

The certificate specifying the appointment of an inspector for the purposes of the Act shall be in the form of Form 1 in the Schedule.

5. Application for grant, renewal and transfer of licence

An application for the grant, renewal or transfer of a licence for a bakehouse shall be in the forms of Form 2, 3 and 4 in the Schedule, respectively.

6. Licence for a bakehouse

A licence for a bakehouse shall be in the form of Form 5 in the Schedule.

7. Notice of appeal

A notice of appeal against the refusal to grant, renew or transfer a licence or against the cancellation of a licence shall be in the form of Form 6 in the Schedule.

13. Repeal

The *Bread Act Regulations 1939* published in the *Government Gazette* on 6 April 1939 and all amendments thereto are repealed.
