Electoral (Ballot Paper Forms) Regulations 1990

1. Citation

These regulations may be cited as the *Electoral (Ballot Paper Forms) Regulations 1990* ¹.

2. Form of ballot papers

- (1) Ballot papers for elections shall be in the appropriate form set out in Schedule 1.
- (2) The forms in Schedule 1 replace the forms set out in Schedule 3 to the Act.

Form A: Ballot paper for an election in a region if there are 3 or more candidates and no groups, and one or more voting tickets are registered.




