1. Citation

These regulations are the *Genetically Modified Crops Free* Areas Regulations 2009.

2. Commencement

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.

3. Warrant to enter

The form set out in Schedule 1 is prescribed for the purposes of section 13(3) of the Act.
