Agricultural and Veterinary Chemicals (Western Australia) Act 1995

Agricultural and Veterinary Chemicals (Western Australia) Regulations 1995

1. Citation

These regulations may be cited as the *Agricultural and Veterinary Chemicals (Western Australia) Regulations 1995* ¹.

2. Commencement

These regulations come into operation on the day on which the *Agricultural and Veterinary Chemicals (Western Australia) Act 1995* comes into operation ¹.

3. Health (Pesticides) Regulations 2011 are eligible law

The *Health (Pesticides) Regulations 2011* are declared to be an eligible law of this jurisdiction for the purposes referred to in section 33 of the Act.

4. Certain enactments have effect despite the Agvet Code and Agvet Regulations of this jurisdiction

- (1) The Occupational Health, Safety and Welfare Act 1984 has effect despite the Agvet Code.
- (2) The *Medicines and Poisons Act 2014* has effect despite the Agyet Code.
