**Energy Operators (Electricity Generation and
Retail Corporation) (Charges) Amendment
By-laws (No. 2) 2016**

Made by the Electricity Generation and Retail Corporation with the approval of the Governor in Executive Council.

1. Citation

These by-laws are the *Energy Operators (Electricity Generation and Retail Corporation) (Charges) Amendment By-laws (No. 2) 2016*.

2. Commencement

These by-laws come into operation as follows —

- (a) by-laws 1 and 2 — on the day on which these by-laws are published in the *Gazette*;
- (b) the rest of the by-laws — on 1 September 2016.

3. By-laws amended

These by-laws amend the *Energy Operators (Electricity Generation and Retail Corporation) (Charges) By-laws 2006*.

4. Schedule 1 amended

- (1) Delete Schedule 1 clauses 3, 6 and 7.
