## **Fiona Stanley Hospital Amendment By-laws (No. 2) 2014**

Made under section 22 of the Act by the Minister in his capacity as the board of the Fiona Stanley Hospital.

### **1. Citation**

These by-laws are the *Fiona Stanley Hospital Amendment By-laws (No. 2) 2014*.

### **2. Commencement**

These by-laws come into operation as follows —

- (a) by-laws 1 and 2 — on the day on which these by-laws are published in the *Gazette*;
- (b) the rest of the by-laws — on the day fixed under the *Road Traffic (Administration) Act 2008* section 2(b).

### **3. By-laws amended**

These by-laws amend the *Fiona Stanley Hospital By-laws 2014*.

### **4. By-law 3 amended**

- (1) In by-law 3(1) delete the definition of *registered owner*.
- (2) In by-law 3(1) insert in alphabetical order:

*responsible person*, for a vehicle, means the person responsible for the vehicle under the *Road Traffic (Administration) Act 2008* section 6;

- (4) In by-law 3(1) in the definition of **vehicle** delete “*Road Traffic Act 1974* section 5.” and insert:

*Road Traffic (Administration) Act 2008* section 4.
