# Motor Vehicle Repairers Amendment Regulations (No. 4) 2014

Made by the Governor in Executive Council.

## 1. Citation

These regulations are the *Motor Vehicle Repairers Amendment Regulations (No. 4) 2014*.

#### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day on which the Consumer Protection Legislation Amendment Act 2014 Part 8 comes into operation.

### 3. Regulations amended
