1. Citation

These regulations are the *Real Estate and Business Agents* (General) Amendment Regulations (No. 2) 2012.

- (a) regulations 1 and 2 on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations on the day after that day.
