## Jetties Amendment Regulations 2011

Made by the Lieutenant-Governor and Administrator in Executive Council.

### 1. Citation

These regulations are the *Jetties Amendment Regulations 2011*.

### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 July 2011.

### 3. Regulations amended

These regulations amend the *Jetties Regulations 1940*.

### 4. Schedule 1 amended

- (1) Delete Schedule 1 Division 1 clauses 1 to 20 and insert:

#### 1. Albany, Albany Waterfront Marina
