1. Citation

These regulations may be cited as the Petroleum (Submerged *Lands) Registration Fees Regulations 1990* ¹.

2. Commencement

These regulations shall come into operation on the commencement of the Petroleum (Submerged Lands) Registration Fees Amendment Act 1990 1.

3. Amounts prescribed (Act s. 4)

- (1) For the purposes of section 4(2) of the Act, the prescribed amount is an amount of \$5 191.00.
- For the purposes of section 4(3) of the Act, the prescribed (2) amount is an amount of \$5 191.00.
- For the purposes of section 4(4) of the Act, the prescribed (3) amount is an amount of \$7 897.00.
- For the purposes for section 4(6) of the Act, the prescribed (4) amount is an amount of \$5 191.00.

(5) For the purposes of section 4(7) of the Act, the prescribed amount is an amount of \$7 897.00.
