Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990

1. Citation

These regulations may be cited as the Petroleum and Geothermal Energy Resources (Registration Fees) Regulations 1990 ¹.

2. Commencement

These regulations shall come into operation on the commencement of the Petroleum (Registration Fees) Amendment Act 1990¹.

3. Prescribed amounts

- For the purposes of section 4(2) of the Act, the prescribed (1) amount is an amount of \$5 191.00.
- For the purposes of section 4(3) of the Act, the prescribed (2) amount is an amount of \$5 191.00.
- For the purposes of section 4(4) of the Act, the prescribed amount is an amount of \$7 897.00.
- For the purposes of section 4(6) of the Act, the prescribed (4) amount is an amount of \$5 191.00.
