## Government Railways Act Regulations

**1. Citation**

These regulations may be cited as the *Government Railways Act Regulations*.

**2. Interpretation**

In these regulations —

“**Act**” means the *Government Railways Act 1904*.

“**Department**” means that branch of the public service employed in connection with Government Railways.

**3. Appointments subject to Minister**

For the purpose of section 73 of the Act the appointment to any office in the Department shall be subject to the Minister if the office is an office specified in the Schedule to these regulations.
