Energy Coordination Act 1994

Energy Coordination (Gas Tariffs) Amendment Regulations 2009

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Energy Coordination (Gas Tariffs) Amendment Regulations 2009*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published in the *Gazette*;
- (b) the rest of the regulations — on 1 July 2009.

3. Regulations amended

These regulations amend the *Energy Coordination (Gas Tariffs) Regulations 2000*.
