# Country Taxi-cars (Fares and Charges) Amendment Regulations (No. 2) 2008 

Made by the Governor in Executive Council.

## 1. Citation

These regulations are the Country Taxi-cars (Fares and Charges) Amendment Regulations (No. 2) 2008.

## 2. Commencement

These regulations come into operation as follows -
(a) regulations 1 and 2 - on the day on which these regulations are published in the Gazette;
(b) the rest of the regulations - on the day after that day.
