Offensive Trades (Fees) Regulations 1976

1. Citation

These regulations may be cited as the Offensive Trades (Fees) Regulations 1976¹.

2. Application

These regulations have effect in every local government² district within the State.

Prescribed fees 3.

The fees set out in the Table to this regulation are payable on the registration of ----

- the offensive trades specified in Schedule 2 of the Act; (a) or
- (b) any process or class of trade declared to be an offensive trade under section 186 of the Act.
