## **Jetties Amendment Regulations (No. 2) 2005**

Made by the Governor in Executive Council.

**1. Citation**

These regulations are the *Jetties Amendment Regulations (No. 2) 2005*.

**2. Commencement**

These regulations come into operation on 1 July 2005.

**3. The regulations amended**
