# **Industry (Advances) Regulations 1981**

#### 1. Citation

These regulations may be cited as the *Industry (Advances) Regulations 1981*.

#### 2. Commencement

These regulations shall come into operation on the day on which the *Industry (Advances) Amendment Act 1980* comes into operation.

#### 3. Interpretation

In these regulations —

"the Act" means the *Industry (Advances) Act 1947*.

#### 4. Decentralized locations

For the purposes of the definition of "decentralized location" in section 2 of the Act —

- (a) the distance referred to in paragraph (a) of that definition is a distance of 100 kilometres; and
- (b) the areas referred to in paragraph (b) of that definition which are special regions are those areas which are within a radius of 8 kilometres of the main or only post

#### 5. Certificate

The form of certificate set out in the Schedule to these regulations is prescribed for the purposes of section 3 (3) of the Act.

#### 6. Revocation
