## INDUSTRIAL AND COMMERCIAL EMPLOYEES' HOUSING ACT 1973

### Industrial and Commercial Employees' Housing Regulations 1974

### 1. Citation and commencement

These regulations may be cited as the *Industrial and Commercial Employees' Housing Regulations 1974*, and shall come into operation on the day on which the Act comes into operation.

### 2. Interpretation

In these regulations —

"the Act" means the Industrial and Commercial Employees' Housing Act 1973.

#### **3.** Fees for attendance at meetings

The following fees for attendance at meetings are prescribed for the purposes of section 10 (2) of the Act —

(a) Chairman ..... \$96 for a full day meeting.

\$64 for a half day meeting.

(b) Other members . . . . \$72 for a full day meeting.\$48 for a half day meeting.
