Births, Deaths and Marriages Registration Act 1998

Births, Deaths and Marriages Registration Regulations 1999

1. Citation

These regulations may be cited as the *Births, Deaths and Marriages Registration Regulations 1999* ¹.

2. Commencement

These regulations come into operation on the day on which the *Births, Deaths and Marriages Registration Act 1998* comes into operation ¹.

3. Term used in these regulations

In these regulations —

10 year search means a search about a particular registrable event that is conducted in the Register, an index to the Register or both in respect of a period of 10 consecutive years or less.

4. Fees

The fees set out in column 3 of the Table to this regulation are payable in respect of the corresponding matters set out in column 2 of the Table.
