# Metropolitan (Perth) Passenger Transport Trust **Official Seal Regulations 1958**

#### 1. Citation

These regulations may be cited as the *Metropolitan (Perth)* Passenger Transport Trust Official Seal Regulations 1958.

#### 2. Interpretation

In these regulations —

"Trust" means the Metropolitan (Perth) Passenger Transport Trust.

#### **3.** Official Seal

- (1) The Official Seal of the Trust shall be the Seal as is, from time to time, adopted by the Trust pursuant to a resolution duly passed for the purpose.
- (2) The Official Seal shall contain the words "Official Seal of the Metropolitan (Perth) Passenger Transport Trust."
- When a resolution is passed by the Trust adopting an Official Seal an impression of the Seal shall be made in the minute book of the Trust immediately after the resolution.

#### 4. **Custody of Official Seal**

The Secretary to the Trust shall keep the Official Seal in his custody and be responsible for its safety.

# 5. Affixing of Official Seal

- (1) The Official Seal shall be affixed to any deed, instrument or document of any description by virtue of a resolution at a meeting of the Trust and in the presence of the Chairman or his deputy and another member of the Trust or his deputy.
- (2) Notwithstanding the provisions of subregulation (1) of this regulation a debenture shall be sealed with the Official Seal of the Trust in the presence of the Chairman and the Secretary.

### 6. Seal book

A record of all deeds, instruments or documents to which the Official Seal has been affixed shall be kept in a book to be known as the "seal book" and the Secretary shall keep the book in his custody.
