Citation

1. These rules may be cited as the *Supreme Court Amendment Rules (No. 7) 1994*.

Principal rules

2. In these rules the *Rules of the Supreme Court 1971** are referred to as the principal rules.

Order 44A amended

3. Order 44A of the principal rules is amended by repealing Rule 1 and substituting the following Rule —

“

Interpretation

1. In this Order unless the contrary intention appears —

- (a) “the Act” means the Foreign Judgments Act 1991 of the Commonwealth; and
- (b) words used in this Order have, in relation to proceedings taken under the Act, the same meaning in this Order as they have in the Act.

”.
