Evidence Act 1906

Evidence (Prescribed Persons) Regulations 2005

1. Citation

These regulations are the *Evidence (Prescribed Persons)* Regulations 2005 ¹.

2. Commencement

These regulations come into operation on the day on which they are published in the *Gazette*, or the day on which the *Evidence Amendment Act 2004* section 4 comes into operation, whichever is the later ¹.

4. Office prescribed (Act s. 50B authorised officer)

- (1) In this regulation
 - *North Metropolitan Health Service* means the health service provider with that corporate name established by order under the *Health Services Act 2016* section 32(1).
- (2) The office of the chief pathologist in PathWest in the North Metropolitan Health Service is prescribed for the purposes of the definition of *authorised officer* in section 50B(1).
