**An Act to amend the *Mines Safety and Inspection Act 1994* to  
increase penalties for offences.**

*[Assented to 7 September 2018]*

The Parliament of Western Australia enacts as follows:

**s. 1**

---

**1. Short title**

This is the *Mines Safety and Inspection Amendment Act 2018*.

**2. Commencement**

This Act comes into operation as follows —

- (a) sections 1 and 2 — on the day on which this Act receives the Royal Assent;
- (b) the rest of the Act — on a day fixed by proclamation, and different days may be fixed for different provisions.

**3. Act amended**

This Act amends the *Mines Safety and Inspection Act 1994*.

**4. Various penalties amended**
