An Act to amend the following to extend the operation of provisions relating to the COVID-19 pandemic —

- The Criminal Code;
- the Criminal Code Amendment (COVID-19 Response) Act 2020;
- the Emergency Management Amendment (COVID-19 Response) Act 2020.

The Parliament of Western Australia enacts as follows:

## Part 1 — Preliminary

## 1. Short title

This is the COVID-19 Response Legislation Amendment (Extension of Expiring Provisions) Act 2020.

## 2. Commencement

This Act comes into operation as follows —

- (a) Part 1 on the day on which this Act receives the Royal Assent;
- (b) the rest of the Act on the day after that day.

15 months
