**State Enterprises (Commonwealth Tax  
Equivalents) (Application) Regulations 1997**

**1. Citation**

These regulations may be cited as the *State Enterprises (Commonwealth Tax Equivalents) (Application) Regulations 1997*<sup>1</sup>.

**2. Commencement**

These regulations come into operation on the day on which the *State Enterprises (Commonwealth Tax Equivalents) Act 1996* comes into operation<sup>1</sup>.

**3. State enterprises prescribed (section 5)**

The State enterprises set out in column 1 of the Table are prescribed for the purposes of section 5 of the Act, commencing on and from the date set out opposite in column 2 of that Table.
