Health Services (Health Service Providers) Order 2016

Part 1 — Preliminary

1. Citation

This order is the *Health Services (Health Service Providers)* Order 2016.

2. Commencement

This order comes into operation on the day after the day on which it is published in the *Gazette*.

3. Terms used

In this order —

Australian Statistical Geography Standard means the Australian Statistical Geography Standard (Cat. No. 1216.0), July 2011 edition published by the Australian Bureau of Statistics;

metropolitan area means the parts of the State set out in Schedule 1 Divisions 1, 2 and 3;

public health service facility does not include a public health service facility at which public health services are provided by the Department CEO or a contracted health entity;

SA2 means a statistical area level 2 under the Australian Statistical Geography Standard.

4. Parts of State declared to be health service areas

The parts of the State set out in Schedule 1, other than a part of the State on which a public hospital or a public health service facility is located, are declared to be health service areas.

The public hospitals set out in Schedule 2 are declared to be health service areas.

- (b) the provision on a statewide basis of free screening mammograms to women, including mobile screening services (BreastScreenWA);
- (c) coordination on a statewide basis of organ and tissue donor activities (DonateLife);
- [(d) deleted]
 - (e) the provision on a statewide basis of public oral health services, including school dental services (in fixed school dental therapy centres and mobile school dental therapy vans), general dental services (in general dental clinics), combined school and general dental services and specialised dental services (Dental Health Services);
 - (f) the provision on a statewide basis of a specialist public health programme that provides holistic health assessment for refugees and humanitarian entrants who are resettled in the State under the Commonwealth Humanitarian Programme (Humanitarian Entrant Health Service);
- (g) the provision on a statewide basis of outpatient services for the treatment, surveillance and prevention of tuberculosis (WA Tuberculosis Control Program);
- (h) the management and operation of a statewide pharmacy service that supplies and disposes of voluntary assisted dying substances as defined in the *Voluntary Assisted*

- (d) supply chain the provision of procurement, warehousing and supply of goods and services to the Department and health service providers.
