1. Citation

These regulations are the *Licensed Surveyors (Licensing and Registration) Amendment Regulations 2023*.

2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 — on the day on which these regulations are published on the WA legislation website;
- (b) the rest of the regulations — on 1 October 2023.
