**1. Citation**

These regulations may be cited as the *Workers' Compensation and Injury Management (Acts of Terrorism) (Final Day) Regulations 2002*.

**2. Final day prescribed (section 3)**

For the purposes of paragraph (b) of the definition of *final day* in section 3 of the Act, the final day is 31 December 2026.
