**An Act to amend the *Guardianship and Administration Act 1990* and the *Guardianship and Administration Amendment (Medical Research) Act 2020*.**

*[Assented to 11 December 2023]*

The Parliament of Western Australia enacts as follows:

## **Part 1 — Preliminary**

### **1. Short title**

This is the *Guardianship and Administration Amendment (Medical Research) Act 2023*.

### **2. Commencement**

This Act comes into operation as follows —

- (a) Part 1 — on the day on which this Act receives the Royal Assent;
- (b) the rest of the Act — on the day after that day.
