#### 1. Citation

These regulations are the *Navigable Waters Amendment Regulations 2023*.

#### 2. Commencement

These regulations come into operation as follows —

- (a) regulations 1 and 2 on the day on which these regulations are published on the WA legislation website;
- (b) the rest of the regulations on 21 December 2023.

### 3. Regulations amended

These regulations amend the *Navigable Waters Regulations* 1958.

#### 4. Regulation 69 inserted

At the end of Part VIII insert:

#### 69. Form of warrant

For the purposes of the Western Australian Marine Act 1982 section 26(5) a warrant must be in the form of Schedule 1 Form 4.

#### 5. Schedule 1 amended

Delete the reference after the heading to Schedule 1 and insert:
