Jetties Amendment Regulations 2024

Made by the Governor in Executive Council.

1. Citation

These regulations are the *Jetties Amendment Regulations 2024*.

2. Commencement

These regulations come into operation as follows —

- regulations 1 and 2 on the day on which these regulations are published on the WA legislation website;
- (b) the rest of the regulations — on 1 July 2024.

3. Regulations amended

These regulations amend the Jetties Regulations 1940.
