Western Australian Marine (Infringements) Amendment Regulations 2024

Made by the Governor in Executive Council.

1. Citation

These regulations are the Western Australian Marine (Infringements) Amendment Regulations 2024.

2. Commencement

These regulations come into operation on 2 May 2024.

3. Regulations amended

These regulations amend the Western Australian Marine (Infringements) Regulations 1985.

4. Schedule 1 amended
