(1) For the purposes of this Act, a person (in this subsection referred to as the "discriminator")

- (c) a characteristic that is generally imputed to persons of the sexual orientation of the aggrieved person,

the discriminator treats the aggrieved person less favourably than, in circumstances that are the same or are not materially different, the discriminator treats or would treat a person who is not of that sexual orientation.

- (2) For the purposes of this Act, a person (in this subsection referred to as the "discriminator") discriminates against another person (in this subsection referred to as the "aggrieved person") on the ground of sexual orientation if, on the ground of
  - (a) the sexual orientation of;
  - (b) a characteristic that appertains generally to persons of the same sexual orientation as; or

- For the purposes of this Act, a person (in this subsection referred to as the "discriminator") discriminates against another person (in this subsection referred to as the "aggrieved person") on the ground of the sexual orientation of the aggrieved person if the discriminator requires the aggrieved person to comply with a requirement or condition
  - with which a substantially higher proportion of persons who are not of the sexual orientation of the aggrieved person comply or are able to comply;
  - which is not reasonable having regard to the (b) circumstances of the case; and
  - with which the aggrieved person does not or is (c) not able to comply.

### 35P. Discrimination against applicants and employees
