The Parliament of Western Australia enacts as follows:

1. Short title

This Act may be cited as the *First Home Owner Grant* Amendment Act 2000.

- (2) Section 8 is to be taken to have come into operation on 1 July 2000.

A person is an "Australian citizen" for the purposes of an application for a first home owner grant if, on the commencement date of the eligible transaction to which the application relates, the person is an Australian citizen under the *Australian Citizenship Act 1948* of the Commonwealth.

(2) Before section 8 the following section is inserted in Part 1 —

7B. Meaning of "permanent resident"

A person is a **"permanent resident"** for the purposes of an application for a first home owner grant if, on the commencement date of the eligible transaction to which the application relates —

- (a) the person is
 - (i) the holder of a permanent visa within the meaning of section 30 of the *Migration Act 1958* of the Commonwealth; or
 - (ii) a New Zealand citizen who is the holder of a special category visa within the meaning of section 32 of the *Migration Act 1958* of the Commonwealth;

and

(b) the person has satisfied the Commissioner that he or she intends to reside permanently in Australia.
