Limited Partnerships Rules 1909

1. Citation

These rules may be cited as the *Limited Partnerships* Rules 1909 1.

[Rule 1 inserted in Gazette 30 Dec 1983 p. 5023.]

1A. **Interpretation**

In these rules, *the Act* means the *Limited Partnerships Act 1909*. [Rule 1A inserted in Gazette 30 Dec 1983 p. 5023.]

2. The Registrar of Companies

Whenever any act is by the Act directed to be done to or by the Registrar ² such act shall be done to or by the Registrar of Companies or in his absence to or by such person as the Attorney General may for the time being authorise.

3. Fees

The fees to be paid to the Registrar under the Act shall be as follows:

- (a) On the original registration of a limited partnership the sum of \$154.
- I(b)deleted]
- By any person inspecting the statements filed by the Registrar in the Register Office the sum of \$4 for each inspection.

As at 01 Jul 2007 Version 01-c0-05 page 1 (d) By any person requiring a Certificate of the registration of any limited partnership or a certified copy of or extract from any registered statement the sum of \$10.50 for each certificate and for such certified copy or extract the sum of \$4 for each folio of 72 words.
