Criminal Code Act Compilation Act 1913

Criminal Code (General) Regulations 2005

1. Citation

These regulations are the *Criminal Code (General) Regulations 2005.*

2. Commencement

These regulations come into operation on 2 May 2005.

3. Interpretation

In these regulations, unless the contrary intention appears — **"Form"**, if followed by a number, means the form of that number in Schedule 1.

4. Forms, completing

If an item in a form in Schedule 1 does not have enough space to complete it, the person completing it must —

- (a) insert in the item "See attachment [*number*]"; and
- (b) attach to the form a separate document titled "Attachment [*number*] — [*name of the item*]".

Example: A single attachment to Form 1 for the item "Thing(s) to be searched for" will be titled "Attachment 1 - Thing(s) to be searched for".

5. Search warrant, application for

- (1) An application under *The Criminal Code* section 711 for a warrant must be made in the form of Form 1 which may be adapted as necessary for the purposes of that section.
- (2) An application under *The Criminal Code* section 716 for a warrant must be made in the form of Form 1 as adapted for the purposes of that section.

6. Search warrant, form of

- (1) A search warrant issued under *The Criminal Code* section 711 must be in the form of Form 2 which may be adapted as necessary for the purposes of that section.
- (2) A search warrant issued under *The Criminal Code* section 716 must be in the form of Form 2 as adapted for the purposes of that section.

7. Forms may be used for other search warrants

If an Act permits an application for and the issue of a search warrant and the Act or subsidiary legislation made under it does not prescribe the form of the application or the warrant, the forms in Schedule 1, with any necessary changes, may be used for the purposes of the Act.

- 4. Insert the words of an affirmation if required.
- 5. Insert the place where the application is made.
