Peel Health Services By-laws 2008

1. Citation

These by-laws are the *Peel Health Services By-laws 2008*¹.

2. Commencement

These by-laws come into operation as follows:

- (a) by-laws 1 and 2 on the day on which these by-laws are published in the *Gazette*;
- (b) the rest of the by-laws on the day after that day 1 .

3. Terms used in these by-laws

In these by-laws —

site means the site of the —

- (a) Murray District Hospital; and
- (b) Dwellingup Nursing Post,

being the land described in Schedule 1.

4. Smoking

A person must not smoke on the site. Penalty: a fine of \$50.

5. Disorderly persons may be removed from site

A person who ---

(a) uses abusive language; or
