## APPROPRIATION (CONSOLIDATED FUND) ACT (No. 4) 1999

No. 13 of 1999

AN ACT to appropriate out of the Consolidated Fund a sum for capital payments made during the year ended 30 June 1997 under the authority of the *Treasurer's Advance Authorization Act 1996.* 

[Assented to 19 May 1999]

The Parliament of Western Australia enacts as follows:

#### **Short title**

**1.** This Act may be cited as the *Appropriation (Consolidated Fund) Act (No. 4) 1999.* 

#### Commencement

**2.** This Act shall come into operation on the day on which it receives the Royal Assent.

#### **Appropriation of purpose**

**3.** The sum of \$19,277,873.88 being payments of an extraordinary or unforeseen nature made under the authority of the *Treasurer's Advance Authorization Act 1996* and charged to the Consolidated Fund under that Act, is appropriated for the capital services and purposes expressed in Schedule 1.
