The Parliament of Western Australia enacts as follows:

Short title

1. This Act may be cited as the Appropriation (Consolidated Fund) Act (No. 3) 1997.

Commencement

2. This Act shall come into operation on the day on which it receives the Royal Assent.

Appropriation of purpose

3. The sum of \$70 601 439.99 being payments of an extraordinary or unforseen nature made under the authority of the *Treasurer's Advance Authorization Act 1995* and charged to the Consolidated Fund under that Act, is appropriated for the capital services and purposes expressed in Schedule 1.
