# **REAL ESTATE AND BUSINESS AGENTS AMENDMENT ACT 1994**

No. 43 of 1994

AN ACT to amend the Real Estate and Business Agents Act 1978.

[Assented to 31 August 1994.]

The Parliament of Western Australia enacts as follows:

#### Short title

1. This Act may be cited as the Real Estate and Business Agents Amendment Act 1994.

## Commencement

2. (1) Subject to subsection (2), this Act comes into operation on the day on which it receives the Royal Assent.

(2) Sections 7 and 8 (b) (i) come into operation on such day as is, or days as are respectively, fixed by proclamation.

# **Principal Act**

**3.** In this Act the *Real Estate and Business Agents Act 1978*<sup>\*</sup> is referred to as the principal Act.

# Minister may give directions

12A. (1) The Minister may give directions in writing to the Board with respect to the exercise of its powers and functions, either generally or in relation to a particular matter, and the Board shall give effect to any such direction.

(2) The text of any direction given under subsection (1) is to be included in the annual report submitted by the accountable authority of the Board under section 66 of the Financial Administration and Audit Act 1985.

## Minister to have access to information

- 12B. (1) The Minister is entitled
  - (a) to have information in the possession of the Board; and
  - (b) where the information is in or on a document, to have, and make and retain copies of, that document.

(2) For the purposes of subsection (1) the Minister may —

- (a) request the Board to furnish information to the Minister;
- (b) request the Board to give the Minister access to information;
- (c) for the purposes of paragraph (b) make use of the staff of the Board to obtain the information and furnish it to the Minister.

(3) The Board shall comply with a request under subsection (2) and make its staff and facilities available to the Minister for the purposes of paragraph (c) of that subsection.

- (4) In this section
  - "document" includes any tape, disc or other device or medium on which information is recorded or stored mechanically, photographically, electronically or otherwise;
  - "information" means information specified, or of a description specified, by the Minister that relates to the functions of the Board.
