# **Bills of Sale (Fees) Regulations 1983**

## 1. Citation

These regulations may be cited as the *Bills of Sale (Fees)* Regulations  $1983^{1}$ .

# 2. Commencement

These regulations shall come into operation on 1 March 1984.
