No. 35 of 2008

An Act to grant supply and to appropriate and apply out of the Consolidated Account certain sums for the capital purposes of the year ending 30 June 2009.

[Assented to 29 June 2008]

The Parliament of Western Australia enacts as follows:

1. Short title

This is the *Appropriation (Consolidated Account) Act (No. 2)* 2008.

2. Commencement

This Act comes into operation as follows:

(a) sections 1 and 2 — on the day on which this Act receives the Royal Assent;

(b) the rest of the Act — on the day after that day.

3. Issue and application of moneys

- (1) The sum of \$2 349 219 000 is to be issued and may be applied out of the Consolidated Account as supply granted for the year from 1 July 2008 to 30 June 2009.
- (2) The sum referred to in subsection (1) is additional to supply granted by the *Appropriation (Consolidated Account) Act (No. 1) 2008.*

4. Appropriation for capital purposes

The sum of \$2 349 219 000 granted by section 3 as supply is appropriated from the Consolidated Account for the capital purposes expressed in Schedule 1 and detailed in the Agency Information in Support of the Estimates for the year.
