## **Rates and Charges (Rebates and Deferments) Regulations 1992**

### **1. Citation**

These regulations may be cited as the *Rates and Charges (Rebates and Deferments) Regulations 1992*<sup>1</sup>.

### **2. Urban drainage charges**

A charge made under the *Land Drainage Act 1925* for the provision of urban drainage is prescribed for the purposes of paragraph (c) of the definition of “prescribed charge” in section 3(1) of the Act.

### **3. Maximum limit for rebate**

The limit on the amount of rebate that an eligible senior is to be allowed on a prescribed charge referred to in section 40(9)(a) of the Act is the amount set in the following Table for that charge for the rating year during which the service to which the charge relates was provided.

**4. Allowances prescribed for the purposes of section 23**

Under section 23(1)(aa)(v) of the Act the following allowances are prescribed for the purposes of section 23 of the Act —

- (a) the Mature Age Allowance;
- (b) the Mature Age Partner Allowance;
- (c) the Parenting Allowance;
- (d) the Partner Allowance; and
- (e) the Widow Allowance.
